PRESS STATEMENT BY THE CENTRAL EQUATORIA YOUTHS ON THE FORMATION OF STATE YOUTH UNION STEERING COMMITTEE BY THE CHAIRPERSON OF NATIONAL YOUTH UNION

- 1. We have chosen to make this Press Statement because the matter at hand is of public interest and has caused profound public concern. The Central Equatoria Youths rejects and condemn unconstitutional and illegal executive order No. 02/2020 on 28th October, 2020, for the formation of Ten State Youth Union Steering Committees plus three Administrative Area particularly in Central Equatoria State by Mr. Gola Boyoi Gola Chairperson of South Sudan National Youth Union
- 2. We wish to point out clearly that the National Youth Union don't have a constitutional mandate to form any State Youth Union Steering Committee in the states without the presence of the states' ministers of Youth and Sports. Based on article 7(1) F of the Youth and Sports bodies regulations act 2003, that give powers to Minister to appoint and dissolved the steering committee of the Youth Union and article (21) give power to minister to appoint Youth Union Election Committee. In absence of State Minister of Youth, the Commission of Youth and Sports in the ministry has powers to form State Youth Union Steering Committee.
- 3. On a similar note, we wish to inform the National Youth Union that CES youths are capable of organizing themselves as well as forming a Steering Committee to prepare for the State Youth Union Convention when the formation of the state's cabinet is done. Therefore, we call for National Youth Union to reconsider its decision on this matter.
- 4. Finally, we reiterate our full support to the leadership of Cde. Emmanuel Adil as being a youth governor for our state. We appeal to his highest authority to reject this constitutional violation by suggesting recourse to legal and practicable way forward that will lead to inclusive, credible and peaceful State Youths Union Convention.

In the exercise of the powers conferred upon me under articles 5, 7 and 11 of General Regulations of South Sudan National Youth Union 2019. I, Gola Boyoi Gola, the chairperson of South Sudan National Youth Union do hereby issue this order No 02 for;

- 1- Dissolution of the Defunct 32 States' Youth Unions.
- 2- Formation of steering committees for ten States' Youth Unions and three
- 3- Formation of seven members' steering committee inclusive of gender and
- 4- The committees' chairpersons (states' youth union steering committees) shall be the former chairpersons of the Defunct States whose headquarters are the current ten States' headquarters.

Terms of reference for the States Unions' and Administrative Areas

Steering Committees

- 1- Shall work in collaboration with authorities and National Youth Union.
- 2- Shall mobilize funds to conduct conventions/congress.
- 3- Shall conduct convention/congress within 90 days depending on funds availability. 4- Shall draft the general regulations for the union.
- 5- Shall represent the youth in occasions and meetings.
- 6- The committee shall work for peace and unity among youth and other
- 7- Shall update/report to National Youth Union through the secretary of States'
