**Subject: Submission of FM Stations Technical Parameters to NCA**

The National Communication Authority is mandated through South Sudan's Communications Act 2012 to among other duties; ensure efficient use of Radio Frequency Spectrum, Numbering System and other scarce communication resources in order to maximize their return. This is to be achieved while ensuring compliance with international and regional agreements and resolutions in the communication sector as adopted by the Republic of South Sudan.

As a compliance measure with the requirements of the Geneva 1984 FM broadcasting agreement for African and European countries as stipulated by the International Telecommunications Union (ITU), South Sudan is in the process of compiling technical and operational information of all FM stations operating in the country. All the stations will be coordinated nationally and internationally with neighboring countries and bilateral agreements established to guarantee interference free operations of South Sudan's stations.

So far, only 29 FM stations (Listed herein) have their technical and operational characteristics fully recorded with NCA. Any FM station licensed or unlicensed that is not on the list is hereby requested to submit their station parameters to NCA before the end of the coordination period (26<sup>th</sup> March 2021).

Only Frequencies with submitted parameters and fully coordinated will be maintained and recognized as operational within the boundaries of South Sudan and stations with uncoordinated frequencies will have to submit applications for a new frequency assignments.

If your station is not among those listed and you would like to maintain your current frequency, kindly visit the NCA office in Gumbo - Juba to pick, fill and return the related form with station details before the set deadline.
