
Reimbursement will be based on presentation of tickets, visas, exit and entrance stamps upon arrival to Juba.

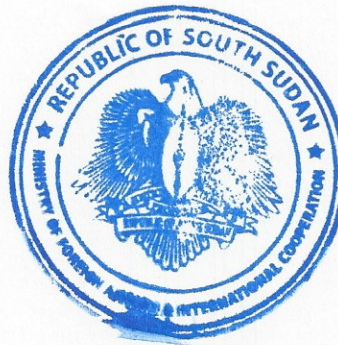
All those recalled have to prepare their handing over notes to the Head of Missions and Chargé d' Affaires.
