This local Order is issued for the authorization of the **Entertainment Authority** as a regulatory body for entertainments and recreational centers in Juba City Council AD 2023

Title and Commencement

This order shall be cited as local order **No.001/2023** for the authorization of the **Entertainment Authority** as a regulatory body for entertainments and recreational centers in Juba City Council jurisdiction and shall come into force on the date of its signature by Acting H.W the Mayor.

The Order

In exercise of the powers conferred upon me by Gubernatorial Degree No: 50/2021 date 19th November 2021 of the Governor, CES read together with section 53(1,2 and 4) of the local Government Act, 2009: And in recognition of section 4(1 and 2) read together with section 13 sub-sections 1, 2 and 3 of the Juba City Council by-laws;

I, **EMMANUEL KHAMIS RICARD**, the Acting Mayor of the Juba City Council do hereby issue this local order for the authorization of **Entertainment Authority** as a regulatory body of entertainments and recreational centers in Juba City Council as herein specified;

1. Formulate policies and regulations of entertainments such as disco techs, music shows at the HOTELS' VENUES, CLUBS, BARS,
2. To label and censor music audios and videos with VSL and hate messages from being played at the radios and TV's stations,



3. To ensure underage are not admitted into Disco Clubs and prohibitions of teens and peer groups parties at the disco clubs, HOTELS VENUES, CLUBS, BARS is enforced
4. To authorize live performance of local and visiting international entertainer's.
5. To authorize beauty pageants, comedy, drama, theatre, films, shows
6. To ensure that entertainments are in conformity with accepted South Sudanese cultures and norms without prejudice to laws of the country
7. To identify, prohibit and close down public disturbance activities such as loud disco tech broadcasted in residential areas of Juba City
8. To ensure South Sudanese local Music (98%) is played by radio stations in Juba City to promote our local content and our culture
9. All the entertainment sectors should obtain their permit and approvals of the entertainment.

Penalties:

In the event of a violation of terms of this local order, Punitive measures shall be used as provided for in the juba city council by-law penal code, criminal Act, child act, and any other applicable law in the Republic of South Sudan.

Implementation and extent.

This order shall come into it force on the date of its signature and authentication by the **Acting H.W the Mayor of Juba City Council.**

All Juba City Council Block Council, Quarter Council Authorities, are ensure implementation of this local order in collaboration with the state and national agencies ,Public order and security organs(NSS, ICTU, MI, CID) law enforcement agencies, Sectors Commanders and Police Division Commanders in and around Juba City Council
