### MINISTERIAL ORDER NO. 3/2023

For the

### Appointment of Members of Preparatory Committee for the Organisation of the Third South Sudan National Youth Union Convention

Pursuant to Articles 7(f), 7(4) and 46(5) of the National Youth Union Regulations, cognizant of the **legal opinion of the National Commission for the Registration of Youth and Sports Bodies** dated 19<sup>th</sup> November 2023, and having regard to the **consensual position** adopted by the former executive and council members;

I, **Dr. Joseph Geng Akech**, National Minister of Youth and Sports issue this "Ministerial Order" for the appointment of members of the **Preparatory Committee for the Organisation of the third South Sudan National Youth Union Convention** as follows:

#### 1. Guiding Principles

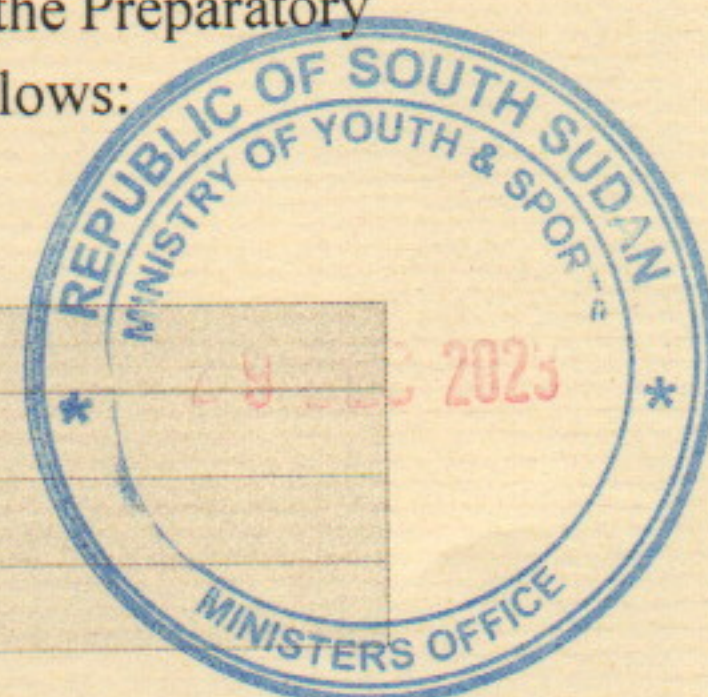
This appointment is made pursuant to the following principles guaranteed in the Transitional Constitution 2011 (as amended) and relevant international standards:

- Impartiality;
- Competence;
- Integrity; and
- Promotion of inclusive participation of all youth in their affairs paying due regard to ethnic, regional and gender diversity.

Having regard to these principles and in accordance to the terms of reference of the Preparatory Committee set out below, the following individuals are hereby appointed as follows:

### 3. Terms of Reference of the Preparatory Committee

#### 3.1 Substantive Mandate

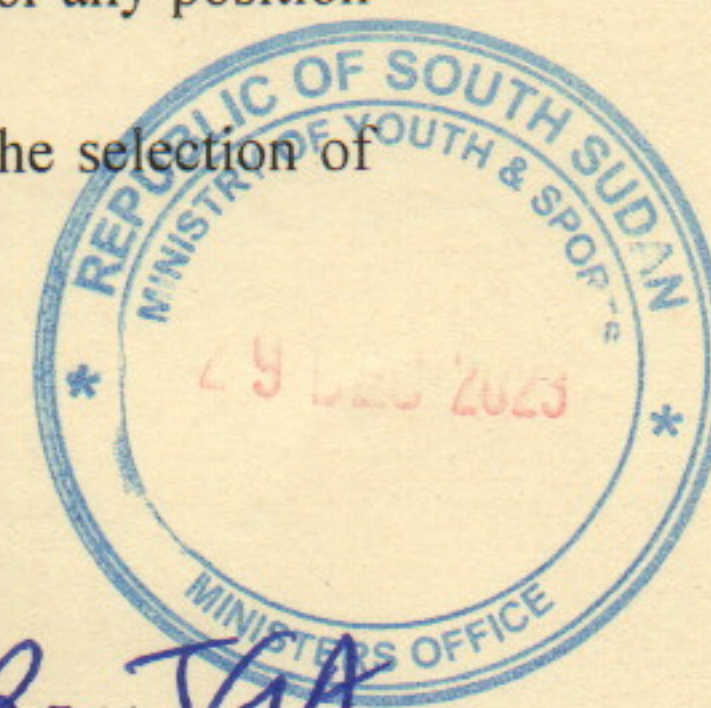
- In consultation with the Minister of Youth and Sports, represent South Sudan National Youth Union in matters falling within the mandate of the Union.
- Develop operational guidelines to guide execution of their mandate.
- Lead the administrative organisation of the South Sudan third National Youth Union Convention by, among others:
  - (a) Prepare the budget of the Convention and submit to the Ministry of Youth and Sports;
  - (b) Receive lists of youth delegates from all States and Administrative Areas and submit to the Minister through Director for Youth and Sports and the Commission for Youth and Sports Bodies;
  - (c) Organise the transport, accommodation and related logistical services for the youth delegates; and
- Prepare and submit financial and narrative reports to the Minister upon conclusion of their mandate.

#### 3.2 Temporal Mandate

- The Preparatory Committee shall serve for a maximum period of **ninety days** from the time of their appointment by the Minister of Youth and Sports.
- This period may not be extended save for reasons objectively verifiable.
- The Preparatory Committee shall be dissolved upon the conclusion of the third Youth Convention.

### 4. Administrative aspects of the Preparatory Committee

- The Ministry of Youth and Sports shall allocate an office space for the operations of the Preparatory Committee for the Organisation of the third National Youth Union Convention.
- No member of the Preparatory Committee shall be eligible to run for any position in the Youth Union.
- Members of the Preparatory Committee shall not be involved in the selection of delegates from the States and Administrative Areas.

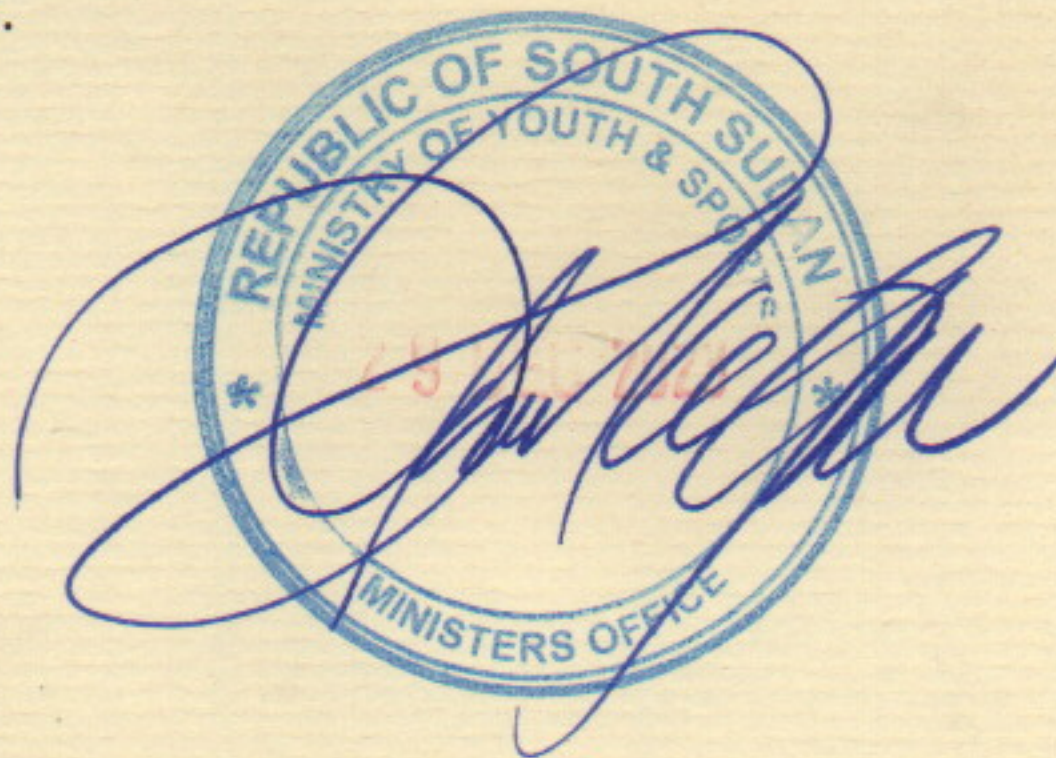
