Appointment of Electoral Committee to Organise Elections for Members of the Executive Committee of the South Sudan Basketball Federation

In keeping with the “Ministerial Directive to the SSBF to Hold Elections within 60 Days” dated 27th November 2023 and pursuant to Article 40(b) of the Transitional Constitution of the Republic of South Sudan, 2011 (as amended) and relevant regulations of South Sudan Basketball Federation 2019:

Terms of Reference of the Electoral Committee:

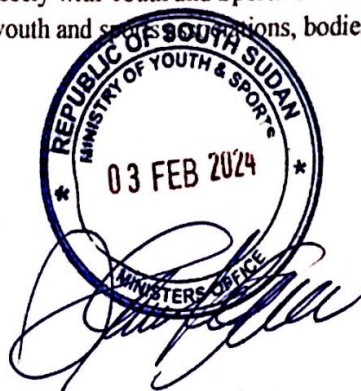
- (a) develop procedural guidelines to govern elections. Such guidelines shall conform to the Basketball Constitution and FIBA regulations;
- (b) receive duly filed applications from applicants contesting for various elective positions of: (1) President of SSBF; (2) Secretary General; and (3) Secretary for Finance;
- (c) publish final list of qualified candidates for elective positions;
- (d) facilitate logistics of delegates for elections;
- (e) conduct elections and announce the results;
- (f) submit financial and narrative report two weeks after the conclusion of elections; and
- (g) perform any function that may be assigned by the Minister.

Miscellaneous Matters:

- 1. The election date for the South Sudan Basketball Federation shall be **19th Day of February 2024.**
- 2. The Committee shall cease to exist upon conclusion of elections for which it was formed by the Minister.
- 3. The Electoral Committee shall work closely with Youth and Sports Council which is mandated to supervise elections of all youth and sports associations, bodies and entities in South Sudan.
