Your excellency,

- 1) Referring to skyrocketing of the market prices in the republic of South Sudan which have become a concern of the public and private sector respectively. For that matter the issue became a collective responsibility to all National keys player spearheaded by government of National unity in order to rescue our people in this serious food insecurity, the South Sudan Supreme Airlines board of directors passed the resolution that part of South Sudan Supreme Airlines, debts must go for the import of strategic food items, fuel products, medicine and building materials in a subsidize prices which will be distributed to ten (10) states, Three (3) Administrative areas and seventy-nine(79) counties for period of one year.


Therefore, the board of Directors for South Sudan Supreme Airlines is hereby requesting your excellency the following approvals

- i) To approve for a loan from Africa Development Bank equivalent to above mentioned amount against South Sudan Supreme Airlines depts. As per attached cheques which was supposed to be pay by the Ministry of finance and planning but due to lack of liquidity the payment was not affected.
 - ii) We also need your excellency to include in the Agreement of the loan for the above mentioned amount worth USD 193,248,955.9 for supply of strategic food items, fuel products and medicine that values the sales items in South Sudanese pounds should be exchange in United States Dollar by the Africa Development Bank because the central bank not have enough reserve
- 2) The republic of South Sudan should not concentrate on import food items to combat food insecurity in the country but this must be supplemented with our livestock and fisheries, commercialization to contribute in food security and economic growth
 - 3) The loan will cover also the export of
 - I) Livestock products and fisheries such as leaser industry
 - II) Forestry products such as Arabic export
